

Event'Pass General Terms and Conditions

“Event'Pass” is a service offered by the FEDERATION FRANÇAISE D'ATHLETISME, a government-recognised public interest association

The Event'Pass service hereinafter referred to as “the Service” is offered on the online registration platforms of the organisers of sporting events acting in the name and on behalf of the FFA and on the website www.jaimecourir.fr by the FFA. It allows you, by taking out a paying subscription, to benefit from the advantages defined below.

The Service is subject to prior acceptance of the terms and conditions herein.

I. Overview:

These conditions exclusively govern the service provided by the FFA under the name “Event'Pass”. These terms and conditions are applicable to registrations for the Service on the jaimecourir.fr website and on the registration platforms for out-of-stadium athletics events. The terms and conditions for ordering FFA products also remain applicable.

You agree to provide true and accurate information about yourself.

These provisions are without prejudice to the legal provisions on the subject and namely those provided for in the French Consumer Code.

You agree to inform the FFA within 15 days of any change in the information provided at the time of subscription, including any change of email address or bank details. If you fail to do so, the FFA may suspend your subscription under the conditions set out in Article 15 'Suspension' of the terms and conditions herein.

The Service is reserved for private individuals and may not be used for purposes other than those set out in the terms and conditions herein. The Service is not available to legal entities, nor to customers ordering items for resale or for commercial, professional or institutional use.

The Service is only available to individuals of legal age.

For Juniors (18-19 years old, age as of 31 December), access to the Service is limited to events of up to 25 km, in accordance with the provisions of the Out-of-Stadium Regulations.

Beyond that, there are no access limitations to the Service.

The FFA may make any changes it deems necessary to the Service. The terms and conditions of the Service will then be those in force on the site on the date of subscription to the Service. Any changes to the Service and/or the benefits in force will be communicated to the members of the Service by email at least fifteen days before they become effective.

2. Access to the Service and Subscription Validation:

2.1 Access to the Service

To access the Service, you must:

- Have or Create a jaimecourir.fr account and register. Please note that this account must have been validated by the FFA's Subscription department.
- Confirm your acceptance of the terms and conditions of the Service and validate your registration to the Service.

Please note that in order to access the Service, you must not hold a FFA licence or an ongoing annual J'aime Courir Pass.

The jaimecourir.fr account allows you to log on to the www.jaimecourir.fr website and gives you access to the various services offered by the FFA. The jaimecourir.fr account is accessible with a login and password that is strictly personal to you.

You can change your password by going to 'My Profile' and then 'My Account' at www.jaimecourir.fr.

You must immediately notify the FFA of any loss or unauthorised use of your account, login or password. Passwords and logins are personal, and you agree not to disclose them. As such, you are solely responsible for their use.

Any attempt to substitute another user's password or login is strictly forbidden. We reserve the right to accept or reject your registration for any legitimate reason and to the extent permitted by applicable law.

2.2 Subscription Validation

You declare that you have read and accepted the General Terms and Conditions of Sale herein before subscribing to the Service. The validation of your order therefore implies acceptance of these General Terms and Conditions of Sale.

A summary of the information relating to the Service and the General Terms and Conditions of Sale will be sent to you in PDF format to the email address used to confirm your order.

When signing up to the Service online (on jaimecourir.fr or on the online registration platforms for out-of-stadium athletics events), the FFA will send the pass holder their subscription number by email, enabling them to benefit from the advantages of the Event'Pass Service online. The pass holder may print the confirmation of subscription at any time,

The retention and use of the Event'Pass is the sole responsibility of the holder.

The Event'Pass service is linked to an out-of-stadium athletics event and gives you access to the *J'aime Courir* advantages in force on the day of your purchase in connection with the said event.

3. Advantages

These advantages, as of the date hereof, are the following:

- A 20% discount on all products offered on the FFA's online shop, which can be accessed from boutique-officielle.athle.fr.
- A personalised training plan adapted to the sporting event for which the Event'Pass has been purchased.
- The benefit of cancellation insurance for the entry fees to the sporting event up to EUR 50 per race bib and per event under the terms described in the coverage notice appended to the General Terms and Conditions of Sale herein.

Please note that purchasing an Event'Pass does not exempt you from the obligation to present the organiser with a medical certificate stating that there is no contraindication to you competing in sporting events, athletics or running in competition, which must be less than one year old on the date of entering the sporting event.

Any activation of the registration cancellation insurance will be notified to the organiser for the needs of the event. Therefore, any attempt to participate in the event will be at your own risk.

The advantages obtained remain valid for the duration of the holder's Event'Pass.

It is only possible to benefit from these advantages from the FFA online shop after having entered your Event'Pass number and logged on via the 'My Account' section.

These advantages are only valid in mainland France and Monaco.

4. Length of Subscription / Termination

The Service you are subscribing is limited in time. The Service runs from the time it is validated by the FFA until the end of the athletics event for which it is purchased.

Subscription to the Event'Pass is for a minimum of 6 (six) weeks and a maximum of 12 (twelve) weeks. The Event'Pass can be taken out up to 6 (six) weeks before the date of the sporting event. The subscription of an Event Pass is therefore no longer permitted within 6 (six) weeks of the date of the sporting event to which it relates. At the end of the validity period, the benefit of the Event'Pass and all its advantages for the member shall end without any automatic renewal. Nevertheless, the member retains the benefit of their free *J'aime courir* account.

Termination: Given the duration of the Event'Pass and the absence of automatic renewal of the Service, no termination at the member's initiative is permitted.

The FFA reserves the right to cancel or refuse any subscription to the Service from a user with whom there is a dispute relating to the payment of a previous subscription or if the applicant already holds a sports licence issued by the FFA or an annual *J'aime Courir* Pass.

Any fraudulent use of the Service (participation in the event despite the activation of the cancellation insurance for example) will expose the user to an action for reimbursement of the sums paid by the insurer against him or her.

5. Territory

The Service is reserved for users who have registered to take part in an out-of-stadium athletics event, organised or authorised by the FFA, and taking place on French territory.

6. Prices - Payment terms

The price of the Service can be found at www.jaimecourir.fr. The fact of validating the subscription to the Service implies the obligation to pay the price indicated.

The FFA may change the price of the Service. In this case, the price of your current service will not be changed during the current period and the Service at the new price will be subject to the pass holder's acceptance at the time of re-subscription of their Event'Pass. Payment for the Service is made by Visa, MasterCard, or other payment cards accepted by the FFA's payment providers.

7. Storage of your bank details

The FFA offers members the option to save their bank details to facilitate future purchases.

To do so, the member must tick the corresponding box on the payment page. Once the payment has been validated, the invoicing and payment card details are saved. The member's bank details are not kept by the FFA but by its payment provider on secure servers.

The pass holder may at any time delete the data relating to the registered payment card and/or add another payment card by clicking on the link provided for this purpose

8. Right of withdrawal - Provisions applicable to Online Subscriptions

The Service starts on the date of subscription to the Service. In accordance with the legal provisions in force, if you have not begun to benefit from the advantages attached to the Service, you have a cooling off period of 14 days from the date of subscription to the Service. Once at least one of the above-mentioned advantages has been used, you will no longer be able to exercise your right of withdrawal.

9. Customer service

For any information or question relating to the subscription and use of the Service, the FFA can be contacted through the contact form on the jaimecourir.fr website

10. Commitments regarding the Use of the Service

By using the Service you agree to make responsible use in accordance with all the provisions of the terms and conditions herein and in compliance with applicable laws.

In particular, you agree to using the Service in a manner permitted by the Terms and Conditions herein, including, but not limited to, not using the Service in an abusive way or for illegal purposes, not passing on the benefit of your personal Service to a third party, not using the Service for commercial purposes, not impersonating a user or using an account that does not belong to you.

11. Suspension - Termination of Access to the Service

The FFA may terminate the Customer's access to the Service without notice, by email or by ordinary post, in the event of a breach of the terms and conditions herein or, more generally, in the event of improper or fraudulent use of the Service.

The FFA may also decide to terminate the Service at any time for reasons of its own, without being liable for compensation. In this case, you will be informed in advance of the termination of the Service.

12. Personal Data

Information and data concerning you are collected by the FEDERATION FRANCAISE D'ATHLETISME. The data is necessary for the management of your *J'Aime Courir* account and the Service as well as for your relations with the FFA. They may be transmitted to the FFA's distant structures and affiliated members acting under the aegis of the FFA in the context of the execution of the Service, in particular the organisation of collective training sessions.

Your information and data are also retained for security purposes (including fraud prevention), to comply with legal and regulatory obligations and to enable us to improve and personalise the services the FFA provides to you and the information the FFA sends you.

In accordance with the French Data Protection Act of 6 January 1978, you have the right to access, amend and object to personal data concerning you in the context of the Service.

Simply write to us online via the contact form on the jaimecourir.fr website or by post to FFA, *J'Aime Courir*, 33 avenue Pierre de Coubertin, 75640 Paris Cedex 13, France, mentioning if possible your surname, first name, the email address of the account linked to the Event'Pass service, your address and if possible your Event'Pass holder number.

In accordance with the regulations in force, you must sign any such request, join a copy of any ID bearing your signature to it and specify the address to which the reply should be sent. A reply will then be sent to you within 2 months of receiving any such request.

Unless you object when you create your *J'Aime Courir* account or when subscribing to the Service, you will receive information from the FFA and its partners electronically (email, text, etc.).

The purpose of this information is to keep you informed of FFA news and advantages available to you under the Service.

If you no longer wish to receive said information, you can opt out at any time by indicating your choice on your *J'Aime Courir* account. It is specified that you will however continue to receive the information necessary for the execution and proper management of the Service (namely information on the implementation and monitoring of your personalised training plan, promotional ticketing offers reserved for FFA licence holders, etc.).

13. Existence of a Do-Not-Contact list

Existence of a Do-Not-Contact list: If your telephone number is collected when you create your account or place an order, we inform you that your telephone details will only be used for the proper execution of your orders or to contact you to offer you new services. Without prejudice to the above, in accordance with legal provisions, you are informed that you may, if you wish, register on the telephone do-not-contact list. You can

register for free on this list, which is binding on all professionals except those with whom you have already concluded a contract.

14. Applicable law - Disputes - Complaints handling - Mediation

This contract is governed by French law. In the event of a dispute, the French courts shall have exclusive jurisdiction.

The language of this contract is the French language.

For any complaint you can contact the FFA. 17. Confirmation

You declare that on subscribing to the Service, you have read and accepted the terms and information on the characteristics of the Service, as well as the present General Terms and Conditions. You declare that you have full legal capacity or the necessary authorisations and that you accept the General Terms and Conditions herein.
